## Letter from the President

Dear Residents:

We would like to thank our Public Works Department and Water Department for their dedication and perseverance in coping with the September flooding. On September 13 and 14, Kenilworth and surrounding communities experienced severe flooding due to heavy rains. Over eight inches of rain fell between the early hours Saturday until 10:00 p.m., and it is recognized as the heaviest rain since August 23, 2007. Our Public Works employees were on site almost around the clock to help respond to the storm and to monitor storm water management systems.

Village infrastructure could not handle the sheer amount of water in the system, and as a result, some homes experienced flooding. Once the sanitary sewer became overloaded due to the excessive amount of rain, water flowed backwards in the sanitary sewer and consequently into the basements of our homes.

Other local municipalities throughout the Chicago region experienced flooding as well. In fact, the locks in Wilmette Harbor were opened early that day to relieve the area served by the Metropolitan Water Reclamation District (MWRD) of the excess water.

- Only allow children to go to homes where it appears the residents of the home are present. Typically, having the front porch light on is a good indication that not only is someone home but also they are willing to partake in the Halloween festivities.
- Inspect all candy at the end of the night. Make sure children do not eat any suspect pieces of candy.
- Costumes should not hinder movement, hearing, or vision. Additionally, costumes should be brightly colored or have glow-in-the-dark or reflective patches to ensure visibility.
- Children, as well as all residents, should only cross the street at designated intersections. Crossing in the middle of the street, or jaywalking, is dangerous and unlawful.
- Accompany children during trick or treating. Not only is it safer but also fun for the entire family!
- Have a safe Halloween!

## Water Meter Replacement Begins

The Village is about to begin a six month program to replace or upgrade all residential and commercial water meters and add Automated Meter Reading (AMR) technology to all water meter accounts. The replacement of the water meters is due to their age and the inability to replace or make repairs with comparable equipment. The new water meters, utilizing AMR technology, will transmit the meter readings daily by radio frequency via data collectors located within the Village. The automated reading system will improve customer service by providing more prompt and accurate readings with no estimated water bills.

Due to the extreme age and suspected inaccuracies of many of the old meters (some are over 100 years old!), a homeowner may notice a change in their regular water bill after the meter is replaced. If this proves to be the case, feel free to contact the Water Department for a complimentary leak check inspection and/or suggestions for water conservation. Other benefits of the new AMR system include eliminating the need for a meter reader to regularly visit your home and continuous leak monitoring of all meters. The AMR devices use a secure radio frequency with a FCC license and will not interfere with any equipment or devices that you may presently use.

The installation of this equipment will be at no cost to you. However, you will be responsible for any costs associated with making your water meter accessible and valves operable. For example: a wall or shelving unit encloses your meter to hide it from view. You would be responsible for moving and replacing the wall or shelving unit and any associated costs.

## Yard Waste Disposal Season Is Ending

The Village of Kenilworth does not have a special curbside leaf pickup program. You may purchase yard waste bags for disposal of leaves and yard waste as always or have your landscaper haul them away. Please, remind your landscaper it is not permitted to place leaves in the alley as the Village will not pick them up. The Village street sweeper will collect only those leaves that have fallen into the street. The Village's yard waste collection program continues through December 14. There is no lawn waste collection between December 15th and March 31st.

The Village has contracted with Water Resources Incorporated of Elgin, Illinois, to provide and install this new equipment. In the coming weeks, you will be contacted by Water Resources Incorporated requesting to set up an appointment to perform the installation. A typical installation should take less than one hour. The new meter will be installed in the location of your current meter. The transmitter, which is 1"x 6"x 6", will be installed on the outside of your home or business. We ask for your cooperation in scheduling an appointment with the contractor as the Village has over 900 sites to complete.

The installers from Water Resources Incorporated will carry ID badges and travel in marked vehicles. We urge you not to let anyone enter your home for meter work unless they show you their Water Resources Incorporated or a Village of Kenilworth identification badge.

Before your appointment, it is important that you review the following in an effort to have the installation done in a timely manner:

- Know where your water meter is located
- Your meter must be accessible.
- Make sure the area around the meter is clear so the installers have room to work.
- Open and close the water valve on both sides of the meter to make sure they function properly.

## FEMA Offers Financial Aid for September 2008 Flood Victims

The Federal Emergency Management Agency (FEMA) has announced that Cook County residents and business owners who sustained losses during the September 13 storm can begin applying for federal disaster aid in the form of individual assistance immediately by either registering online at [www.fema.gov](http://www.fema.gov) or by calling 800-621-3362.

## Abide by Construction & Loud Noise Hours

Village ordinance prohibits work done with loud machinery that disturbs the peace and quiet in the Village before the hours of 7:00 a.m. and after 6:00 p.m. Monday through Friday, and Saturday from 9:00 a.m. to 5:00 p.m. No work is permitted on Sundays. In addition, no work is permitted on the holidays of New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. Loud noise includes construction machinery, snow blowers, leaf blowers, and powered lawnmowers. Failure to abide by these work hour regulations may result in receiving a fine.

## Recycling Available at Village Hall

Old cell phones, DVDs, MP3 players, print cartridges, digital cameras, and laptop computers can all be brought to Village Hall to be recycled. This program is sponsored by the non-profit group, Recycling Avenue. The disposal container is by the front desk, and items can be brought in any time of day. Computer monitors, printers, personal computers, and toner cartridges are not accepted. In addition to E-waste, there is a separate disposal container for compact fluorescent light bulbs sponsored by the Solid Waste Agency of Northern Cook County (SWANCC).



## New Signage Regulations Enacted

As of September 30, 2008, new signage regulations are in effect. In residential areas, resident name plates, home occupation, and security protection signs shall not exceed one square foot in area. Only one real estate sign is permitted per lot which shall not exceed six square feet in area or be greater than five feet in height. Message and political signs are permitted if less than six square feet in area, four feet in height, and no more than 30 square feet of such signs allowed on the property. Also, these signs are not to be illuminated. Election signs are limited to one per candidate or referendum position and must be removed within seven days of the election to which it applies.

## Latex Paint Disposal

Are there a few cans of latex paint in your basement from a home project that you have no use for? Be environmentally friendly and properly get rid of them. Many local theatre groups or churches could use the excess paint in some project. If this is not an option, you can let the paint dry out on its own, and you may put it in your trash container. If you have a large quantity of paint or it will not dry, you could take it to the Wilmette Millen Ace Hardware at 1219 Wilmette Avenue for a fee. ## Board Action Update

In this issue, the business of the Board of Trustees during the months of September & October 2008 are highlighted. Meeting minutes can be found on the Village website [www.villageofkenilworth.org](http://www.villageofkenilworth.org).

### September 2008 Meeting. The Village Board...

- Approved minutes of the August 2008 Village Board Meeting with changes.
- Decided to discuss the results of the Advisory Referendum at the Regular Board Meeting on November 10 instead of November 5 as previously discussed.
- Voted to approve an ordinance amending the Kenilworth Village Code concerning traffic and parking of vehicles along Richmond Road.
- Voted to approve an ordinance amending the Kenilworth Village Code concerning the sale, purchase, and possession of tobacco products and smoke free regulations. Those under the age of 18 are not permitted to buy or possess tobacco products within the Village. Also, the Village of Kenilworth fully complies and agrees to the "Smoke Free Illinois" regulations.
- Approved an ordinance amending the Kenilworth Zoning Code regarding fence height and sign regulations in residential districts. Information regarding signage regulations are explained in "New Signage Regulations Enacted" on Page 3.
- Decided to amend the ordinance regarding the delay period regarding the demolition of structures from six months to twelve months.
- Approved the Village Manger's recommendation to purchase up to 300 tons of salt.
- Approved payment of \$171,829.40 for August, 2008 bills.

### October 2008 Meeting. The Village Board...

- Approved minutes of the September 2008 Village Board Meeting with changes.
- Received the annual financial report (audit) for fiscal year 2008.
- Approved a resolution to authorize a contract with Prescient Development for purchase and installation of Microsoft Exchange Server and clustered file servers in the Amount of \$43,183.07.
- Approved the Community Affairs Committee recommendation regarding boundary changes to the proposed Kenilworth National Register Historic District Nomination. These Changes Decrease the Size of the Proposed District by Omitting Certain properties along the railroad tracks including Townley Field and the Village Yards.
- Approved the Community Affairs Committee recommendation regarding notice to property owners of proposed Kenilworth National Register Historic District. This notice informs property owners of the impending vote for the proposed National Register Historic District.
- Approved payment of \$ 448,178.92 for September, 2008 bills.

## Recycling Question

**Question:** Why do I see my recycling thrown into the garbage truck with all the other garbage? Does Kenilworth recycle?

**Answer:** Yes! Kenilworth does recycle. When Perrin Brothers picks up the garbage and the recycling, they put the garbage deep into the truck. If there are recycling bags, they will often pick up several homes' recycling and place them at the edge of the back of the truck and then create a pile of recycling bags in a corner in order for easier and more efficient pick-up later in the day for all recycling.

# Kenilworth Police Offers Firearms owners are reminded:

## Disposal Of Firearms And Ammunition

If you want to safely dispose of guns, ammunition or other weapons the Kenilworth Police Department is here to help. Regardless of the age or condition of a firearm, the Department provides residents the ability to safely dispose of an unwanted firearm. How does it work?

- Residents may turn in weapons for destruction at the police station. It is best to telephone first to let the Department know you are bringing in a weapon. If you wish to bring in a firearm, it is important to remember when transporting a firearm in Illinois that it must be unloaded, enclosed in a case, and only by persons who have a valid Firearms Owner Identification card (FOID). During transport, a weapon should be broken down into a nonfunctioning state and not immediately accessible to the driver or a passenger within the vehicle.
- If you are uncomfortable transporting the item for disposal, contact the Department and an officer will respond to collect the item.
- If you are worried about the condition of the item you have or are not quite sure about what you have in your possession, get in touch with the Department and an officer will be pleased to advise you.
- The State of Illinois requires that any Illinois resident who acquires or possesses a firearm or firearm ammunition within the State must have in their possession a valid Firearm Owner's Identification (FOID) card issued in his or her name. The Illinois State Police issues FOID cards. Residents can pick up the FOID application form at the Police Department or visit the Illinois State Police website at <http://www.isp.state.il.us/foid> to download an application or get additional information concerning FOID cards.
- The Kenilworth Police Department participates in Project Child Safe. Project Child Safe is a nationwide program whose purpose is to promote safe firearms handling and storage practices among all firearms owners through the distribution of free gun locking devices (firearms safety kits). - The Police Department's shooting range is available, by appointment, for use by Kenilworth residents. There is no fee, however users must have a valid FOID card and make prior arrangements through the Department's range master. 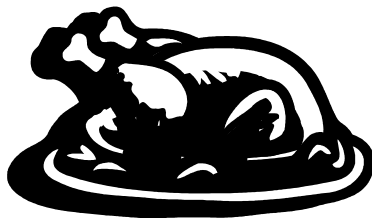

## Snow and Ice Removal Procedures

Winter is here, and the Village's snow crews are ready to battle again with Mother Nature. The following are reminders of some procedures followed by the Village during snow and ice removal in public areas.

### When do snow plowing operations begin?

When snow accumulates on streets to a depth in excess of approximately two inches, and initial salting operations have taken effect, street plowing will begin with arterial and collector streets. This operation continues until all public streets in the Village have been cleared. Approaches to intersections with "Stop" or "Yield" signs are the next priority for salting. When severe icy conditions exist, salt will be spread at all intersections and other necessary locations throughout the Village.

### Why do plows fill in my driveway?

Snowplows need to make multiple passes along each street to push snow back to the curbs so melted water can enter the storm sewer system and drain away. Unfortunately, it is not possible for the plow truck to do their plowing and not leave some snow in driveways.

### What can I do to help the snow removal effort?

Observe parking restrictions and avoid putting snow on the street. When shoveling your driveway, deposit the snow on the parkway to the right side as you face the street. That way, snowplows will not end up pushing as much snow back onto the driveway.

During the winter months, residents are reminded to remove all lawn ornaments (urns, vases, decorative ornamentation) away from the edge of the sidewalk. Items left close to the sidewalk impair plowing and may become damaged during the snow removal efforts.

### What about Sidewalk Plowing?

The sidewalks are plowed when one and a half (1.5) or more inches of snow falls and the snow is frozen adequately to permit plowing without causing damage to parkway or private property. The areas around The Joseph Sears School, major sidewalks to and from the school, sidewalks along Green Bay Road, and sidewalks on major streets leading to the train station are usually given priority, depending on date and time when the snow event occurs.

The Village uses a utility vehicle with a five foot "V" plow attachment that has a rubber cutting edge on the bottom of the plow. Since most sidewalks in the Village are just over five feet wide, sometimes the plow blade damages the grass as the plow moves along. When the ground is frozen, this usually has no affect on the grass, but with changing weather conditions the grass softens along the sidewalk. Even though the Public Works Department tries to clear the sidewalks as quickly and efficiently as possible with minimal disruption, sometimes grass or other items can be damaged. If you see any damage on your property, the Public Works Department will repair any damaged grass after the snow season is over: typically in March or April. Please keep decorative vases, statues, urns, or other objects at a minimum of 18" away from the sidewalk edges. ### Do not park in public alleys.

Blocking alleys makes it difficult to plow or salt these areas. Vehicles blocking alleys will be ticketed.

### Who do I call if I have an emergency?

## Chronology of Discussion of Proposed Kenilworth National Register Historic District

The following is an overview of the history of the discussion of the concept of a National Register Historic District for the Village of Kenilworth. The history provided lists various Village Board and committee meetings where the topic of historic preservation and a National Register District have been discussed. The nomination of the Kenilworth Historic District is currently with the Illinois Historic Preservation Agency (IHPA) and is expected to be reviewed by the Illinois Historic Sites Advisory Council (IHSAC) at the quarterly meeting in Springfield on December 5, 2008. The Village will be sending out a letter to all property owners in the next few weeks providing notice of the nomination and explaining how residents can express their concurrence or objection to the creation of the proposed district.
