3. Effective 7/6/00, section 1205/8-23 of the Park District Code requires *all* park districts to conduct background checks on all applicants for employment.

The District is required by state statute (70 ILCS 1205/8-23) to obtain criminal conviction information concerning applicants, and shall perform a criminal background check for applicants for all positions, including the position for which you have applied. Conviction of offenses enumerated in subsection (c) of said statute shall automatically disqualify the applicant from consideration for working for the district. All other convictions shall not automatically disqualify the applicant from consideration, but rather, the conviction will be considered in relationship for the specific job. Applicants are not obligated to disclose sealed or expunged records of conviction.

4. I certify all information submitted on this application is true and complete, and I authorize investigation of all statements contained in this application for employment as may be necessary in arriving at an employment decision and hereby release and waive any claim against the Kenilworth Park District which may allegedly arise from such investigation. I further understand that if any false information, omissions, or misrepresentations are either contained in my application or given during any interview and are discovered, my application may be rejected and, if I am employed, my employment may be terminated at any time. In consideration of my employment, I agree to conform to the Kenilworth Park District's rules and regulations, and I agree my employment is "at-will" and my employment and compensation can be terminated with or without cause, and with or without notice, at anytime, at either my or the Kenilworth Park District's option.
