WAIVER AND RELEASE OF ALL CLAIMS

By signing this form, I acknowledge that I have read, understand and agree to the following: Registering for and participating in the Kenilworth Park District Summer Camp Program (hereinafter referred to as the "Program"), I am WAIVING and RELEASING all claims for myself and my minor child/ward arising out of such registration and participation. In consideration of the Kenilworth Park District (the "Park District") accepting my minor child as a participant in the program, I hereby agree as follows:

Acknowledgement and Assumption of Risk of Injury and Loss: As a parent/guardian of a participant in the program, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, including death, damages or loss, including property loss, which may be sustained as a result of participation in any and all activities connected with or associated with the Program.

Waiver of and Release of Claims: I hereby agree to, and do, waive, release and relinquish all claims, demands, rights of action, damages, liabilities and controversies of every kind, known and unknown, present and future, that I, or my minor child/ward on whose behalf I am signing, may have against the Park District and its officers, agents, servants, employees, insurers, related or affiliated individuals or entities, successors and assigns arising out of, connected with, or in any way related to the Program or my minor child/ward's participation therein (including transportation services and vehicle operations, when provided).

Indemnity and Defense: I hereby further agree to indemnify and hold harmless and defend the Park District and its officers, agents, servants, employees, insurers, related or affiliated individuals or entities, successors and assigns from any and all claims, lawsuits, demands, damages, liabilities, losses and expenses, including attorneys' fees and administrative expenses of every kind, known and unknown, present and future, arising out of, connected with, or in any way related to my minor child/ward's participation in the Program.

Emergency Care: In the event of an emergency, I authorize the Park District to secure, from any licensed hospital, physician and/or other medical personnel, any treatment deemed reasonable and necessary for my minor child/ward's immediate care and agree that I will be responsible for payment for any and all such treatment rendered.
